# Thornton's new Community Center and Anythink Library open and thriving



In 1974, when Thornton opened its first Community Center, Diane Salazar was just a kid—one who quickly found the Center to be a game-changer for her and her friends. Growing up in Thornton, they spent countless hours enjoying the programs and activities the Center offered. Its impact on Salazar's life was so strong that she returned as an adult to work there. Today, she's still at the heart of the community, working at the new Community Center and Anythink Library, which opened in October at 2211 Eppinger Blvd. "It warms my heart because I've met so many incredible people from all walks of life," Salazar shares. "I'm truly grateful for this experience."

Since opening its doors, the new Thornton Community Center and Anythink Library have become key resources for residents, offering a variety of amenities and programs to promote health, education, and community connection. "It's been wonderful to see the community embrace the new center," says Thornton Recreation Administrator Jenny Dowdell. "We designed this space with input from residents, and it's already making a positive impact on the lives of those who use it."

Built on the site of the original 1974 community center, which was closed and demolished in 2022, the new building reflects a modern vision shaped by extensive community input. # Construction underway on the Anythink Nature Library: A transformative addition to Thornton's Aylor Open Lands

As 2025 kicks off, the construction of the highly anticipated Anythink Nature Library is underway at the Aylor Open Lands property, at 136th Avenue and Quebec Street. This marks a significant milestone for the project, which is poised to become a beacon of environmental education and community wellbeing in Adams County.

In June 2022, Anythink and Thornton entered into a lease agreement for 15 acres of the Aylor Open Lands property. This prime location will soon be home to a 33,000-square-foot nature library, while the remaining 140 acres of open space will be developed into trails and other natural areas dedicated to outdoor learning and exploration.

The Anythink Nature Library is designed to immerse visitors in the natural world, offering spaces, experiences, and collections that foster a deep connection with nature. The library will serve as a natural extension of the Aylor Open Lands, encouraging people of all ages to engage with the environment. The overarching goal is to cultivate a culture of environmental stewardship within the Thornton community.

The Anythink Nature Library is slated for completion by mid-2026, promising a transformative space where nature and learning converge to benefit the entire community.

#### Ward 1 Special Election will fill vacant council seat


Voters in Ward 1 will be asked to fill a vacancy on Thornton City Council by special election to be held on March 25, 2025. This will be a mail-ballot election. The election was triggered after Kathy Henson, the former City Council Member elected to Ward 1 in 2021, was elected to serve as an Adams County Commissioner in the November 2024 election. Henson resigned from her City Council position on November 27,



2024 and council declared the vacancy at their December 17, 2024 meeting. Thornton voters recently passed a Charter Amendment which requires vacancies on City Council be filled no later than 120 days after the resignation of a council member if there is more than a year left in their term of office.

Henson is due to take office as Adams County Commissioner on January 14, 2025 and reflected on her time on Thornton City Council. "I'm honored that the residents of Ward 1 allowed me to represent them on the Thornton City Council. I am proud of the investments we made for the future including the Thornton Community Center, the Thornton Shopping Center Redevelopment, and the South Washington Corridor project, along with a myriad of policy, plans, and programs to address quality of life in Thornton. The work is not finished, but I wish the best for my colleagues on the City Council in their ongoing service and look forward to advancing the partnership and shared goals between the City and Adams County," said Henson.

This Special Election is only for voters in Thornton Ward 1.



Individuals interested in running for the vacant City Council position need to submit a candidate petition with voter signatures by January 13, 2025.

## Thornton City Council to include land acknowledgment in council meeting agendas

Thornton City Council voted to begin each meeting with a land acknowledgment, recognizing the Native tribes thought to originally inhabit the land where the Thornton is today. Council's intention with this change to council meetings is to honor Indigenous communities and highlight Thornton's commitment to fostering inclusion, respect, and historical recognition. By incorporating this acknowledgment,

Council aims to be mindful of the land's history and its ongoing significance to Colorado's Native peoples and reflects a growing trend among Colorado cities to honor the state's Indigenous heritage. To read the entire Land Acknowledgment, visit **goCOT.net/nativeland**.

#### New rules for residential driveways in Thornton

Thornton City Council recently updated residential driveway regulations to give homeowners more flexibility while maintaining neighborhood aesthetics and drainage standards. Here's a quick look at the changes if you're considering a driveway project:

#### **Permit Process**

Driveway permits are now handled by the Planning Division instead of Building Inspection, simplifying the application process.

#### Walkway Allowance

You can now add a 3-foot walkway next to your main driveway in front of your home's livable area. Additional pavement beyond this isn't allowed.

#### **Updated Side Setbacks**

- Between the street and the front of the house:
  - Homes with two-car garages or larger: Require a minimum 3-foot side setback.
  - Homes with one-car garages or no garage: Require a minimum 1-foot side setback.
- Behind the front plane of home: No side setback is required.

#### **Drainage Requirements**

Driveways within three feet of a side property line must have a sixinch curb or other drainage feature to prevent water from flowing onto neighboring properties.

#### **Driveway Width**

Maximum driveway width now depends on the walkway and setback requirements, replacing the previous 30-foot limit.

These changes aim to help homeowners improve their driveways while supporting neighborhood standards. Make sure to review the guidelines before starting any updates!

#### Increased water rates and connection fees support growing a resilient water system and meeting new water quality standards

Like many cities across the country, Thornton continues to see increases in the cost of maintaining and improving our water system. To continue providing our community with clean, reliable drinking water, Thornton City Council has approved a water rate increase for all customers and a connection fee increase for new development, effective January 1, 2025.

The impact of the water rate increase on your monthly bill may vary depending on the season. Typically, water usage is much higher during the summer as outdoor irrigation and water use surges. Individual bills are determined based on actual monthly usage.

This rate increase is crucial to maintaining our diverse water system, investing in Thornton's infrastructure and water treatment technologies, and keeping up with rising costs due to inflation. This water rate increase will also support the utility's ongoing mitigation of PFAS contaminants to meet revised standards from the Environmental Protection Agency (EPA).

The increase in connection fees addresses inflation, rising water rights costs, and stricter regulations requiring the reduction of contaminants like PFAS. New fees for lots under 5,000 square feet reflect lower outdoor water use to help promote higher-density development and support housing affordability with lower connection fees. Multi-family unit fees are based on water use per dwelling unit, ensuring fair and proportionate costs compared to single-family homes.

These adjustments ensure Thornton can maintain a reliable and compliant water system. Being water-wise indoors and outdoors is the best way to reduce your water usage and, in turn, lower your water bill. Income-qualified customers may be eligible for the Water Assistance Program, which helps individuals and families struggling to pay their water bills. #### Thornton continues work to ensure water quality and safety in 2025 and beyond

Thornton's Water Utility is actively working to further reduce PFAS in the water supply. Current PFAS levels meet the EPA's standards, and Thornton plans to add specialized PFAS treatment at the Thornton Water Treatment Plant. This new treatment will



help ensure reliable PFAS removal, even during droughts when PFAS concentrations in rivers can increase, or when certain water sources are temporarily unavailable due to maintenance.

Three design teams have proposed plans for the project, which will include advanced Granular Activated Carbon (GAC) filters with a daily capacity of 30 million gallons. Team selection is anticipated for December. Design will take place in 2025, construction in 2026, with the project expected to be complete by 2027. For more information, visit goCOT.net/PFAS.

You may also have heard recently that the Environmental Protection Agency (EPA) has introduced new regulations to reduce lead exposure in drinking water nationwide. Fortunately, Thornton is already ahead of the game; our water system has been thoroughly inspected, and no lead service lines have been found in the city.

In Thornton, we are proud to report that system-wide lead levels remain low. According to the 2024 Water Quality Report, the range of lead detected was 0-6.3 parts per billion (ppb), far below the EPA's action level of 15 ppb. In fact, 90% of our samples were below 1.7 ppb. #### **Keeping Thornton Water Safe: A Team Effort**

While we're doing our part to keep lead out of the water delivered to your home, we also need your help. Although there are no lead service lines in Thornton's public water system, homes built before 1986 might have lead plumbing or fixtures inside. Over time, these can corrode and release lead into your water, especially when hot water runs through them.

If your home was built between 1983 and 1987, you may qualify for free lead testing as part of our annual water safety program. This is a great opportunity to ensure your drinking water is lead-free. To learn more or to register, email waterquality@ThorntonCO. gov or call 303-255-7770.

### Thornton secures Adams County grants for recreation and infrastructure projects

Thornton will benefit from nearly \$2.9 million in grant funding awarded by the Adams County Board of Commissioners, supporting projects aimed at improving recreational facilities, infrastructure, and community access. The grants will fund three projects designed to enhance quality of life and expand opportunities for residents:

#### **Extending the Reach of Grange Hall Creek Trail**

A \$2,498,686 grant will fund the extension of Grange Hall Creek Trail, including new underpasses, trail crossings, and waterway improvements. The upgrades will boost flood resilience and provide underserved neighborhoods with better access to outdoor recreation and essential services.

#### **Infield Dreams**

Thornton Parks, Recreation, and Community

Programs will receive \$25,000 to improve maintenance on 26 baseball fields. The funding will be used to purchase an infield-specific groomer, which will enhance field quality, reduce staff labor, and free resources for other park maintenance needs.

#### Pickle and a Biscuit

A \$329,407 grant will support the design of eight new pickleball courts, with four slated for construction at Carpenter Park. The project also includes upgrades to the in-line hockey rink at Woodglen Brookshire Park, which will receive new sideboards, fencing, and baseboards.

These projects align with Thornton's commitment to improving recreational opportunities, bolstering community infrastructure, and fostering healthier, more connected neighborhoods.

### Thornton recognized for delivering high-quality, safe drinking water

Thornton's commitment to providing the community with some of the safest and highest-quality drinking water earned the city the prestigious Gold Award for exceptional utility performance from the Association of Metropolitan Water Agencies (AMWA). This honor highlights Thornton's dedication to delivering water that meets the highest standards of safety and quality, reflecting excellence in the management and operation of its water utilities.

This focus on public health and safety further

solidifies Thornton's standing as a trusted water utility. Additionally, Thornton boasts one of the lowest residential water consumption rates on the Front Range, further demonstrating its



leadership in water conservation and efficiency. This recognition reaffirms Thornton's unwavering commitment to providing residents with safe, high-quality water today and into the future.

### Thornton Water Treatment Plant undergoes essential upgrades and maintenance

In late September, the Thornton Water Treatment Plant (TWTP) took a planned two-week hiatus for critical maintenance and upgrades to ensure our community continues receiving top-quality water. Normally running 24/7, the plant temporarily paused operations, allowing contractors to install new redundant chemical feed lines within the Chlorine Contact Chamber (CCC) – a step toward increased reliability in water processing.

The plant's biofiltration system, essential for purifying water, functions as a living microbial ecosystem, so the Operations team cad to carefull refresh the filters every two days with dechlorinated water to maintain ideal oxygen levels. These beneficial bacteria are key in keeping Thornton's water clean and safe, so maintaining their health was a top priority during the shutdown.

The downtime further allowed Operations and Maintenance teams to access areas typically filled with water, to clean and inspect basins, and replace a broken sludge collector cable.

During this time, contractors working in the CCC uncovered nearly 100 broken or missing bolts and clamps used to secure critical sample and chemical lines. The team quickly replaced these parts with durable stainless steel to enhance future durability.

Restarting the plant after this extensive maintenance was a gradual, carefully coordinated process. First, the basins and equipment underwent thorough disinfection. Each part of the system was then brought back online one at a time, with chemical levels adjusted to match changing water conditions. To ensure the treated water met strict safety standards, the first run of water was discharged through the storm drain, fully dechlorinated with neutralizers on standby.

These essential upgrades and maintenance steps underscore our commitment to providing the community with safe, reliable, and high-quality water every day.

#### Thornton's Business Improvement Grant Program powers local business success

#### Shopping carts belong in stores, not neighborhoods: help corral them

Abandoned shopping carts are not only unsightly, but also pose safety risks to pedestrians and motorists. Left unchecked, they can lead to more severe blight issues. That's why in May 2024, the Thornton City Council passed an ordinance to establish a comprehensive program for removing shopping carts from public areas. The program authorizes the city to charge retail owners for each cart retrieved.

Thornton Code Compliance has launched a new shopping cart retrieval program to ensure abandoned carts don't go unnoticed. Thornton has partnered with Kept Companies for a citywide shopping cart retrieval effort.

Here's how it works:

- Weekly Sweeps: Kept Companies conducts weekly sweeps in areas most affected by abandoned carts.
- On-Demand Pickups: In less affected areas, cart retrieval is done on a complaint basis. Coverage can be adjusted based on demand.
- Cart Disposal: Unidentifiable carts, or those not claimed by stores, will be disposed of by the city.

#### Get ready to explore the Active Adult Sensory Walk

This project, nestled between the Thornton Active Adult Center (AAC) and the skatepark, is designed to offer a peaceful, engaging experience for all ages, connecting you with nature in a whole new way. The path, is accessible and easy to navigate, winding through a landscape filled with playful elements like carefully crafted boulders, stumps, and logs. These features aren't just for show—they create a series of low-balance challenges that are both fun and functional.

At the eastern end, near the AAC, you'll find a cozy concrete patio with a stenciled labyrinth, perfect for a moment of reflection or simply enjoying the view. Comfortable benches and a four-post shade structure make this spot ideal for relaxation. As you head west toward the skate park, the sensory walk culminates in a stump pyramid on a gentle knoll, complete with a three-post shade structure and informal seating for those who want to take in the scenery.

Throughout the walk, you'll discover colorful mini gardens, additional seating, and plenty of shade trees, making this a serene spot to unwind. The landscaping embraces the "Naturally Thornton" ethos, featuring low-water areas of grass and wildflowers that surround



the path and gardens, all kept lush and vibrant with full irrigation coverage.

### Let's keep our roads and walkways safe while doing our part to protect the environment this winter

However, the most common salt, sodium chloride (also known as halite), can have harmful effects on the environment. It can damage freshwater ecosystems, kill plants, break down concrete, and even leave stubborn stains on your carpets.

Luckily, there are greener alternatives that are just as effective. The Environmental Protection



Agency's (EPA) Safer Choice program recommends using products like acetates, potassium chloride, or magnesium chloride. These options are kinder to the environment while still helping you keep your sidewalks and driveways safe.

# ThorntonCO.gov wins prestigious Pinnacle Award for digital innovation

**ThorntonCO.gov**, the city's website, has been nationally recognized with the Pinnacle Award for Small/Medium Population Cities and Counties by the National Association of Government Web Professionals (NAGW). - Scrap Metal & Appliances: Drop off old appliances and scrap metal for free, weekdays 7:30 a.m.-3:30 p.m.
- Mattresses: Drop off by appointment for \$30 per piece; call 720-977-6200 to schedule.
- Organics: Bring food scraps and yard waste (only 3-gallon compostable bags) on weekdays 7:30 a.m.-3:30 p.m.

## Empowering Thornton: a new monthly expo for our unhoused community members




